## 1. Review Application for Conditional Use by Special Review for Elite Craft Farms LLC.

Request of approval for conditional use and beginning cultivation licensing process for facility in Nunn, CO. There are possible future plans for expansion. Growing inside and outside. Plant count will be under the approved amount of plants from the State. They will have a centralized security system with cameras. Goal is to be good neighbor. Currently leasing for 2 years- they would like to eventually buy the property. They also have a HVAC company.

# 2. Application submittal for Manufacturing License at Ace's Place and 1 inch tap.

Request of conditional use and of manufacturing license at facility in Nunn, CO. Grow will be inside and outside. Outside just once a year, inside continually. Indoor grow will start as soon as possible, but will wait for the outdoor growing until possibly next spring, 2020. Use of 3 buildings (one for grow, one for manufacturing and one green house). Will need a 1 inch tap. This will hopefully become central location for operations.

### 3. Boy Scout Flag Retirement Box.

# 4. Update on Nunn First Responders Community Day.

There have been two (2) committee meetings. There are a good number of vendors that have applied. But we are still a little short of food vendors. They will be heading to Ault Days to try to acquire more food vendors. There is going to be a full page ad in the North Weld Herald which should be out this week or next week.

### 5. Updates for Police Radio System.

Weld County has started implementing a change to a different radio system. We will need to purchase new radios for the cars. Right now it's \$4,500.00 per radio but if we purchase now we can get buy 4 radio systems, get one free. Prices do keep rising but we are not in a time crunch. The final transfer will happen in 2023.

## 6. Burning within town limits.

• Chief Joe Clingan has verified with Weld County That it is ok to burn in fire pits as long as they are 3 foot wide and 1.5 feet deep. There also needs to be a water hose nearby during the burn. However, burn barrels are considered incinerators so to use them anywhere; they need to contract Weld County for a burn permit.
